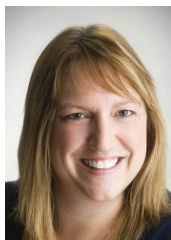

“Recognizing and Reporting Child Abuse”

COURSE DESCRIPTION: This course will help you gain an understanding of your role as a mandated reporter in meeting your legal obligations in the area of child protection as per the Child Protective Services Law (CPSL). You will describe and apply current information on the CPSL, recognize elements and indicators of child abuse and neglect, and demonstrate reporting procedures.



SPEAKER: Angela Yorina, RDH, MS, PHDHP, received her MS from Misericordia University in Dallas, PA. Angie implemented a dental clinic at The Hope Center in Luzerne, PA and was the recipient of the PDHA Community Dental Health Award in 2008. “Radiation Safety for the Dental Professional”

COURSE DESCRIPTION: This course will be a review of radiation exposure and safety guidelines for dental radiographers. Emphasis will be placed on maximizing diagnostic benefit while minimizing radiation risk. This course fulfills the continuing education requirement on radiation safety set forth by the PA Department of Environmental Protection/Bureau of Radiation Protection.
